WELCOME TO GOOLE TOWN TIGERS JUNIOR FOOTBALL CLUB

I would like to take this opportunity to welcome both you and your child on behalf of Goole Town Tigers Junior Football Club.

Goole Town Tigers JFC has been established since 2000. We are affiliated to West Riding FA and we are a FA Charter Standard Club. The club also hold the ERCAS Level 1 certificate. The Club at present runs 24 teams ranging from our Tiny Tigers in the Under 6's through to our Under 16's. We offer friendly football sessions supervised by FA qualified, FA DBS approved coaches who receive emergency first aid and child protection/safeguarding training.

Over 40 Tiger players have gone on to sign academy forms for Hull City, Hull City Ladies, Scunthorpe United and Doncaster Rovers over the years.

Teams play in the Selby & District Junior Football league our girl teams play in the West Riding Girls Football League. The Club has a small committee that meets with all coaches/managers on a regular basis to discuss Club matters.

Goole Town Tigers JFC as with all grassroots clubs is run by volunteers.

TRAINING:

Training sessions take place once a week at our home ground, West Park, Goole. Please ensure your child attends with a drink and shin pads (no fizzy drinks). During the winter months we utilise a number of local amenities which include the 3G pitch at Snaith Secondary School & Howden Senior School, Goole Academy and Victoria Pleasure Grounds.

SUBSCRIPTIONS/REGISTRATION

In accordance with FA Charter Standard, every player is required to complete a registration/emergency contact form. We require up to date contact details of parent/guardians plus the child's relevant medical details if applicable. Medical consent is required in the event that your child requires medical attention whilst training or playing matches.

As with all Clubs there is a subscription fee which is collected by standing order at **£12.00 per month for 10 months September to June**. Subscription fees cover all age group annual running expenses e.g. West Riding FA affiliation fees, entry fees to Selby & District Junior Football League, training/match venues, referee charges, tournament fees, insurance cover, winter training costs, coaching courses & DBS checks, first aid kits, trophies, footballs, goalposts, cones, bibs etc.



WhatsApp

At Goole Town Tigers JFC we use WhatsApp to communicate with you parent(s)/guardian(s).

WhatsApp is a free, multiplatform messaging app that lets you send text messages and more with just a Wi-Fi connection.

We have used WhatsApp for numerous years and have found that this is the most convenient way for our coaches to communicate with you parent(s)/guardian(s) about football.

WhatsApp is safe and secure with its end-to-end encryption and strict attention to protecting subscriber privacy.

Once you have joined our club you will be asked to join the relevant groups WhatsApp.

This is only for club members and each team have their own group.

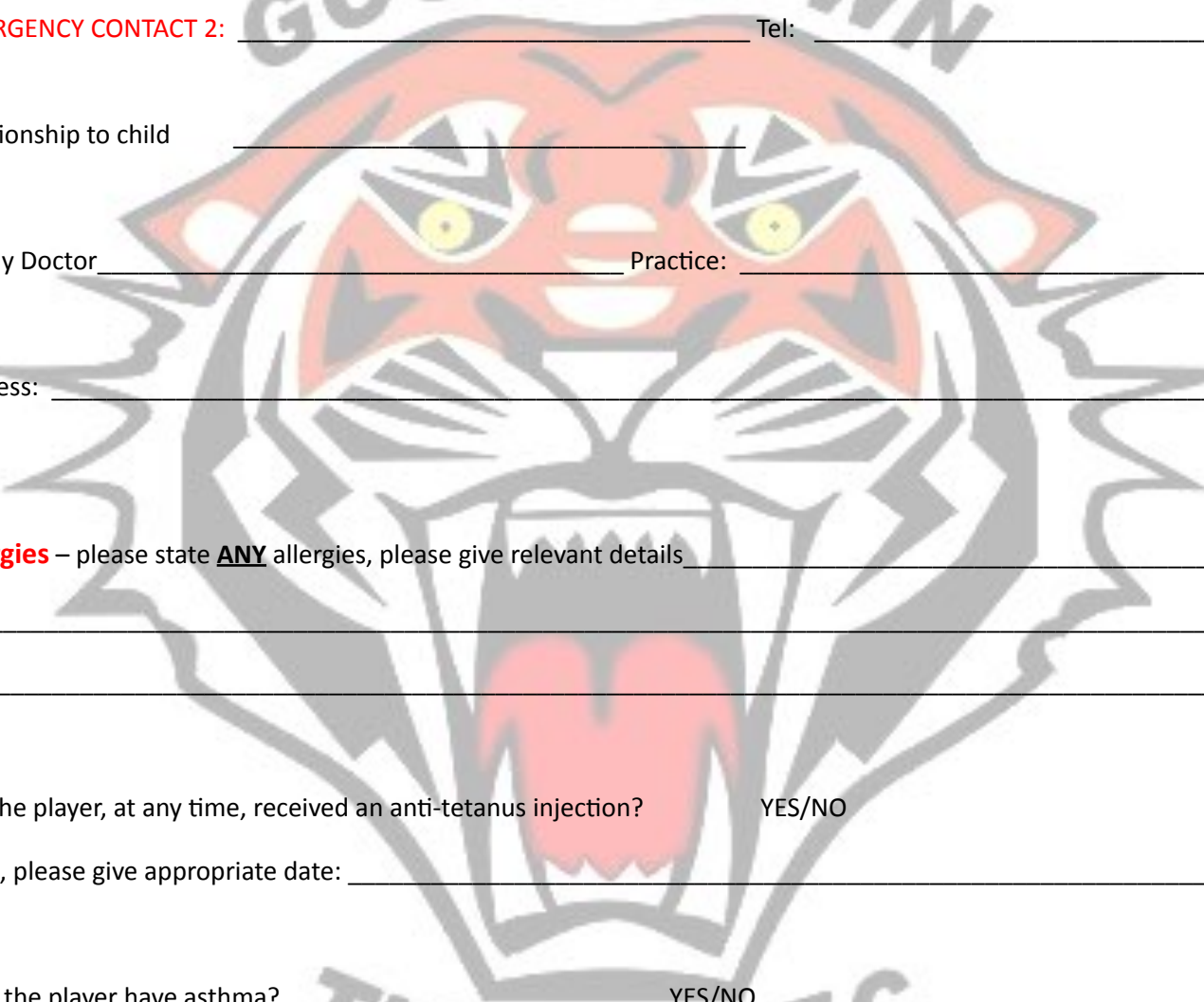

SOCIAL NETWORKING

The FA has seen an increase in the number of complaints and referrals it has received in relation to postings on social networking sites such as Twitter & Facebook.

As a FA affiliated and Charter Standard Club, Goole Town Tigers remind all our participants of the following key points:

- All comments on social networking sites may be considered public comment by The FA and County FA
- Any comments which are improper, bring the game into disrepute or are threatening, abusive, indecent or insulting may lead to disciplinary action
- Comments about match officials which imply bias, attack the officials' integrity or are overly personal in nature are considered improper

- Comments which include a reference to a person's ethnic origin, colour, race, nationality, faith, gender, sexual orientation or disability may be considered aggravated and attract a higher disciplinary sanction
- Re-tweeting or re-posting another person's post may lead to disciplinary action if the original comment was improper
- Deleting or apologising publicly for an improper posting, whilst advisable, does not prevent disciplinary action being taken

An individual is **strictly** responsible for any posting on his/her account or page.

Participants should take care to ensure that others do not access their account, as the fact that a posting or comment may have been by a third party will not prevent disciplinary action being taken against the account holder.

Participants are required to act in the best interest of the game at all times
